

John G. Cramer's book, "The Quantum Handshake," provides essential insights into how we might best interpret the mathematical equations of quantum physics. While the mathematical foundation of quantum physics is considered to be non-controversial and fundamentally sound, the interpretations of how and why quantum mechanics operates the way it does are bewilderingly numerous. Some of the most commonly discussed interpretations include: the orthodox Copenhagen Interpretation, several varieties of the Many Worlds Interpretation, the Holographic Interpretation, and John G. Cramer's Transactional Interpretation. The long-standing philosophical conundrum associated with quantum physics interpretations can be attributed to the difficulty of testing and verifying these interpretations. Put another way, while it is the job of the interpretations to describe the mathematical formalism of quantum physics, only the formalism--not the interpretations--makes

experimentally testable predictions. And adding to the confusion, as John Cramer so eloquently points out, is that "The major failings of many would-be interpretations of quantum mechanics are: (1) they confuse a cause with its effects (example: the knowledge interpretationâ™s assumption that changes in knowledge cause the wave function to change); (2) they confuse the map with the territory (example: Kastnerâ™s assumption in the Possibilist Transactional Interpretation that the wave function resides in the Hilbert-space map of correlations); and (3) they are designed to explain one particular problem while ignoring all others interpretational problems.
